Even with all of the HS2 disruption going on around us we still have partial access to the Quainton ground which is great bonus; however, if anyone knows of any other potential shooting sites the committee would be keen to hear of these options so as to look at potentially exploring these as we never quite know what HS2 will be doing next.

I am still receiving letters threatening closure of this ground from HS2 as they want requisition all of the land and the access driveway but, touchwood, to date, has not been enforced. I have also applied for compensation giving a figure of 10K. They suggest getting reputable land agent to assist in filling in this form for compensation, but as this is not a cost the club wishes to incur, I have continued to fill this in. Should anyone be able to assist and support this the next time it is issued by HS2 please let me know so we can work on it together.
